## Updates from Delta Dental of Iowa

### Multi-Factor Authentication Coming This Fall

To help protect your practice and patient data, all Delta Dental online accounts will require the use **multi-factor authentication (MFA) by October 20, 2025**.

MFA is a secure, multi-step login process that adds an extra layer of protection by requiring a temporary verification code sent via email or phone. This added layer of security makes it more difficult for hackers to access accounts with stolen passwords alone, protecting sensitive patient information.

Starting **September 18, 2025**, MFA will be available as an **optional feature** for your account. We encourage you to enable it early to familiarize yourself with the process and enhance your account security. [Learn more](#).

## Claims Submission & Treating Dentist

It's essential that claims are billed under the dentist who performed the services. According to the American Dental Association (ADA), the treating dentist must certify the claim accurately reflects the procedures they performed. Submitting claims under a different provider, even if they are part of the same practice, can be considered misrepresentation and may lead to consequences, including audits, denied claims, and allegations of fraud.

## Medicare Fraud Scheme Involving Phishing Fax

[Alert ID 62380](#): The Centers for Medicare & Medicaid Services (CMS) has identified a fraud scheme targeting Medicare providers and suppliers. Scammers are impersonating CMS and sending phishing fax requests for medical records and documentation, falsely claiming to be part of a Medicare audit.

**Important:** CMS doesn't initiate audits by requesting medical records via fax. **Protect your information.** If you receive a suspicious request, **don't respond**. If you think you got a fraudulent or questionable request, work with your [Medical Review Contractor](#) to confirm if it's real.
